

# TOUR CONDITIONS

**HOTELS:** Will be provided in accordance with the itinerary or similar. All rooms are standard twin bedded rooms with private facilities. A limited number of single rooms are available for an additional cost. Triple rooms usually consist of a standard double room with an additional sofa bed.

**ITINERARY AND HOTEL VARIATIONS:** During certain periods, due to unforeseen circumstances, AMI Travel or its representatives may have to change the sequence of the tour. Due to circumstances beyond our control we may also need to cancel special events. We reserve the right to cancel or modify events that appear in the itinerary. There may be other circumstances in which hotel changes become advisable or necessary. Therefore, we also reserve the right to substitute any of the hotels.

**PAYMENT POLICY:** A deposit of \$300 per person is required at the time of the booking. Balance is due 45 days prior to departure.

**CANCELLATION:** Cancellation by passengers: up to 46 days prior to departure -\$300 per person. Between 45 days and 31 days prior to departure date - \$500 per person. Between 30 days and 8 days prior to departure \$750 and penalties as imposed by the airline or other suppliers. Between 7 days and departure date - no refund.

AMI Travel reserves the right to cancel the trip or to increase the package price for lack of minimum participants.

**RESPONSIBILITY:** AMI Travel Inc. and its representatives act only as agents for the tour members in making arrangements for hotels, transportation, restaurants, sightseeing or any other services in connection with the itinerary. AMI Travel assumes no liability whatsoever for any injury, damage, loss, accident, irregularity or delay to person or property for any reason including, but not limited to, acts of war or terrorism, any act or default of any hotel, carrier, restaurant or any other company or person rendering any of the services included in the tours. The tickets, coupons, tariffs, rules or contracts currently in use by any carrier, hotel, restaurant or other contractor rendering services shall constitute the sole contract between such contractor and the tour member.
